

Official Contest Rules

- Prince George, BC
- Burns Lake, BC
- McBride, BC
- Smithers, BC
- Terrace, BC
- William's Lake, BC
- Prince Rupert, BC
- Fort St. John, BC
- Mackenzie, BC
- Fort Nelson, BC

and communities lying within a 150km radius of the aforementioned communities only, except employees of the sponsor(s) and its/ their subsidiaries and affiliates, advertising and promotional agencies and their immediate families. Contest Players must be 18 years of age or older as of October 11th, 2022. Odds of winning depend on the number of eligible entries received.

Contest players are defined as the people submitting entries on the YXS Facebook page within the specified entry period and abiding the official rules.

Winners must consent to travel to the Prince George Airport to redeem their prize, must be willing to travel out of the Prince George Airport, and must be legally allowed to travel during the time period specified by the Official Rules. Winners also must possess a valid passport and be legally allowed to enter the United States of America during the travel period.

Winners are defined as the group composed of individual winning the prize package and who was randomly selected according to the process outlined in the Official Rules, as well as a second person of their choice who will be participating in the prize.

Winners must have valid ID in order to collect their prize and travel to and from Prince George, BC during the times specified in the Official Rules. One prize package per winner.

Winners will be notified within 2 business days of the drawing date (October 17th, 2022).

Should the winners be unable to travel to Prince George, BC during the specified travel period, or if a winner is found to be ineligible according to the Official Rules, they forfeit their right to win and another draw will be conducted from the entries on the YXS Facebook page. “Entry Period”). To submit an entry to the Contest, a Contest Player will comment on either the HYPG official contest post or the YXS official contest post an activity they hope to win in Tucson. Duplicate entries on both of the official posts will not be counted. This submission constitutes an “Entry”. There is a limit of three entries per person; to constitute separate entries, activities must be commented in separate comments. The activity commented to gain an entry must be available in the city of Tucson, Arizona, USA, and a radius of 100 km. Only one prize will be awarded during the entire period. Entries received online shall be deemed to be submitted by the holder of the Facebook account. All Entries must be submitted no later than the end of the Entry Period. All Entries become the property of YXS. Entries will only be accepted on-line. Illegible entries are ineligible. Unintelligible, incomplete or late Entries will be disqualified. Unless indicated, no Entries will be accepted by any other means than the YXS Facebook page and the HYPG Facebook page.

By submitting an entry, the Contest Player confirms that they will legally be allowed to perform the activity specified in the entry within the state of Arizona, United States of America, as of the beginning of the “travel period” (December 2nd, 2022). In the event that the Contest Player is not legally allowed to perform their stated activity, that entry will be considered void and will disqualify the Contest Player from winning this contest.

The legal drinking age and the legal betting age in Arizona is 21 years of age.

WINNER SELECTION:

- a. A random draw from all eligible entries received will take place within 5 business days of the contest closing date of October 11th, 2022. Winners will be contacted and announced within 2 business days of the draw. Odds of winning are solely dependent upon the number of eligible entries received.
- b. The winner will be notified by Facebook Messenger.
- c. Neither YXS nor its affiliates will be responsible for the failure for any reason whatsoever of selected Winners not being able to receive notification or for the selected Winners not being able to respond as prescribed above. Before

- d.
