

## **YXS Official Contest Rules: Share and Go Anywhere**

Our mission at YXS is to enhance our region by providing an excellent airport experience. To best complete this mission, we need to hear from the people who use our airport- you! As part of our Master Planning process, YXS is conducting a survey to gather feedback from individuals and organizations in the community about current airport services and what they would like to see implemented in the future. To thank you for your participation, we are giving all individuals who have completed the survey a chance to enter into a contest to win free flights and food!

“Contest Player(s)” are defined as the individual(s) submitting their names and contact information through the form contained at the end of the survey found at <https://www.surveymonkey.com/r/YXSMasterPlan>.

“The Winner” is defined as the individual winning the prize package and who was randomly selected according to the process outlined in the Official Rules. Winners will be notified within 2 business days of the drawing date (February 10<sup>th</sup>, 2023).

This contest is in no way sponsored, endorsed, administered by or associated with Facebook.

### **ELIGIBILITY:**

To be eligible for this Contest, an individual must: (i) be a legal resident of Canada; and (ii) be 18 years of age or older on or before January 11<sup>th</sup>, 2023.

Contest Players are only deemed eligible for this contest if they submit responses to all questions contained in the “Prince George Master Plan Update & Economic Impact Residents and Business Survey”. This amounts to 17 questions if the Contest Player is responding on behalf of a household and 27 questions if the Contest Player is responding on behalf of an organization.

No purchase necessary. Contest is open to Canadian residents only. Employees of the sponsor(s) and its/ their subsidiaries and affiliates, advertising and promotional agencies and their immediate families are not eligible for contest entry. Contest Players must be 18 years of age or older as of January 11<sup>th</sup>, 2023. Odds of winning depend on the number of eligible entries received.

Individuals must submit their complete name and contact information. Incomplete or illegible entries are not eligible.

The Contest is void where prohibited by law.

### **HOW TO ENTER:**

The Contest begins on January 10<sup>th</sup>, 2023 and closes at 11:59 PM PST on Thursday, February 9<sup>th</sup>, 2023 (the “Entry Period”). To submit an entry to the Contest, a Contest Player will complete either the Household or Business/Organization questions in the survey found at the aforementioned link, including submitting their name and contact information using the form found in the final question of the survey. This submission constitutes an “Entry”. There is a limit of one entry per person. If a Contest Player is found to have submitted duplicate entries, all entries will be considered void. Entries received online shall be deemed to be submitted by the individual whose legal name is recorded in the “Name” box of the contest submission form. All Entries must be submitted no later than the end of the Entry Period. All Entries become the property of YXS. Entries will only be accepted on-line. Illegible entries are ineligible. Unintelligible, incomplete or late Entries will be disqualified. Unless indicated, no Entries will be accepted by any other means than the form found in final question of the “Prince George Master Plan Update & Economic Impact Residents and Business Survey”.

#### WINNER SELECTION:

- a. A random draw from all eligible entries received will take place within 2 business days of the contest closing date of February 9<sup>th</sup>, 2022. The Winner will be contacted within 2 business days of the draw. Odds of winning are solely dependent upon the number of eligible entries received.
- b. The Winner will be notified by at least one of the methods of contact submitted in their contest entry.
- c. The Winner must respond to attempted contact by YXS within 5 calendar days of the time of initial contact. If this does not occur, The Winner will be deemed ineligible.
- d. The Winner may choose to decline the prize package for any reason when they are contacted. If this occurs, The Winner shall be treated as an ineligible contest player.
- e. Prize redemption will occur at the Prince George Airport. If the Winner cannot travel to the Prince George Airport, they may be deemed ineligible if alternative, reasonable arrangements cannot be made by the Prince George Airport Authority and other contest sponsors. The Winner must possess valid, government issued photo ID at time of redemption.
- f. If a winner is found to be ineligible according to the Official Rules, they forfeit their right to win and another draw will be conducted from the pool of Contest Players. This will be repeated until a qualified winner can be found.
- g. Neither YXS nor its affiliates will be responsible for the failure for any reason whatsoever of selected Winners not being able to receive notification or for the selected Winners not being able to respond as prescribed above. Before being declared a winner, the selected Winner must agree to the dates and times of the scheduled flights and will be required to sign an agreement and release confirming compliance with the Contest Rules and acceptance of the prize as offered and (i) releasing YXS and its respective subsidiaries, affiliates, employees directors,

officers, suppliers, agents, sponsors and administrators from any and all liability for any loss, harm, damages, cost or expense arising out of participation in this Contest or participating in any prize-related activity or the acceptance, use or misuse of any prize, including without limitation costs injuries, losses and damages related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising therefrom. Such agreement and release must be returned within two (2) business days of the notification date indicated on the documents or the selected Winner will be disqualified, and the prize forfeited.

#### PRIZES:

- a. Prizing will be issued after the contest closing date of February 9<sup>th</sup>, 2023.
- b. The prize consists of:
  - a. One \$500 universal flight credit through Uniglobe Sunburst Travel and Cruise.
  - b. One \$100 Farmhouse Catering gift certificate.
  - c. One gift basket with assorted confectionary from Rocky Mountain Chocolate Factory, with a value of approximately \$50-\$100.
- c. Section a. of the prize must be used for a purchase falling within the following constraints: airfare for any individual(s) of The Winner's choice; on an airline of The Winner's choice; to or from any destination given that the airport of initial departure and/or final arrival and/or representing at least one stop each way on the routes purchased is the Prince George Airport (YXS).
- d. Section a. of the prize must be used to purchase flights falling within the 2023 calendar year. After December 31<sup>st</sup>, 2023, this credit will be considered void.
- e. Neither YXS nor it's affiliates or sponsors are responsible for any other prizing including airport fees and transfers, taxes, gratuities nor travel insurance, outside of the specific items mentioned above.

Prizes must be accepted as awarded and cannot be transferred, substituted or redeemed for cash. YXS or its affiliates reserve the right, in their sole discretion, to substitute any and all of the prizes for prizes of equal or greater value should all or part of a prize become unavailable for any reason.

#### GENERAL CONDITIONS:

- a. All entries become property of YXS upon receipt and will not be returned and no correspondence will be entered into except with selected Winners.
- b. Any attempt to deliberately damage any social media or internet sites or to undermine the legitimate operation of this Contest is a violation of criminal and civil laws and, should such an attempt be made, YXS reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.
- c. Entries are subject to verification and will be declared invalid if they are illegible, incomplete, mechanically reproduced, mutilated, forged, falsified, altered or tampered with in any way.

#### INDEMNIFICATION BY PARTICIPANTS:

By entering the Contest, each Contest Player and Winner:

(a) releases and holds harmless YXS and administrators and their respective directors, officers, employees, parent companies, subsidiaries, affiliates, suppliers, sponsors and agents from any and all liability for any injuries, loss or damage of any kind to persons, including death, or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of any prize, participation in this Contest, or participating in any prize-related activity; and

(b) agrees to fully indemnify YXS and administrators and their respective directors, officers, employees, parent companies, subsidiaries, affiliates, suppliers, sponsors and agents from any and all claims by third parties without limitation.

By entering this Contest, Contest Players and Winners agree to be bound by these Contest Rules, which will be posted on the YXS Facebook page. Contest Players and Winners further agree to be bound by the decisions of the judges, which shall be final and binding in all respects. YXS reserves the right, in its sole discretion, to disqualify any Contest Player or Winner it finds to be:

(a) tampering or attempting to tamper with the entry process or the operation of the Contest or the Contest social media platform;

(b) violating the Contest Rules;

(c) violating the terms of service, conditions or use and/or general rules or guidelines of any YXS property or service, or

(d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.

#### ON-LINE ACCOUNT HOLDER INFORMATION:

In the event of a dispute regarding who submitted an Entry, the Entry will be deemed submitted by the individual whose name legally reflects the name attached to the Entry. Selected Contest Players and The Winner may be requested to provide YXS with identification confirming they are the individual associated with a given entry.

In the event that a Contest Player is responding on the behalf of a business, the individual filling out the responses is deemed to be the Contest Player and must enter their personal name into the entry form to be eligible. The owner of the business responding to the form is not necessarily the associated Contest Player for the business unless they are the individual filling out the form and entering their name.

Any entries not containing the name of the individual associated with them will not be considered eligible.
